*Respected Sir,*

It is to inform that Anantapur II REZ Transmission Limited, a subsidiary of Resonia Limited has been recently awarded the works for development of Inter-State Transmission Scheme (ISTS) "Transmission System for Integration of Anantapur-II REZ – Phase-I (for 4.5 GW)" through Tariff Based Competitive Bidding (TBCB) route. This project is scheduled to be completed within 24 months from the date of transfer of SPV i.e. 31.03.2025. Under this scheme, followings Inter-state transmission lines and substations are being implemented:

- Establishment of 4x1500 MVA, 765/400 & 6x500 MVA, 400/220 kV Ananthapuram-II Pooling Station near Kurnool, Andhra Pradesh along with 2x330 MVA (765 kV) bus reactors at Ananthapuram-II PS with provision of two (2) sections of 4500 MVA each at 400 kV level.
- Ananthapuram-II – Davangere 765 kV D/C Transmission Line
- Ananthapuram-II – Cuddapah 765 kV D/C Transmission Line
- +300 MVA STATCOM at Ananthapuram-II PS

2. The transmission system will be used for evacuation of green power from Anantapur REZ, Andhra Pradesh. This project will play a pivotal role in supplying reliable green power to Andhra Pradesh and Karnataka.

3. As different elements of this project will be set up in the state of Andhra Pradesh and Karnataka, continuous support of State Governments, in terms of timely resolution of Right of Way (RoW), Land issues, Statutory Clearances and Forest / Wildlife Clearances etc., would be required by Project Developer from time to time, so that the project is completed within the schedule time.

4. I would, therefore, request to kindly direct the concerned officers to extend requisite support to the Project Developer, to ensure timely completion of the project.
